## President's Report

### **Planting Season Complete**

Our 2022 planting season (the first 'normal' season since Covid struck in 2020) is now complete.

On Sunday 31<sup>st</sup> July, over 200 FSCVR members, supporters, Friends of Damper Creek and members of the public came to our National Tree Day planting along Fairway Reserve. It was a cool but clear morning, and everyone worked very hard to get over 8,000 plants into the ground along Fairway Reserve. Beginning at 10:00am, we had completed the planting by a little after 12 noon!

The scouts provided a barbeque of sausages and vegie burgers which proved very popular with everyone. Planting gives you an appetite (specially the young ones).

It was a great effort, and I want to thank everyone who came along to help. Particularly, I'd like to thank the Monash Bush Crew for their work in preparing the site, providing the planting tools, and generally ensuring we all knew what we were doing! I should also note that the plants were purchased using a grant from Melbourne Water.

The previous week, Brentwood school planted 1800 plants along the Crosby arm of Scotchmans Creek, and AGIG planted 800 plants in the same area.

Year by year, the bushland corridor along Scotchmans Creek is improving in quality as the bush is regenerated. It takes several plantings (and some patience) to restore a natural looking bush environment, but as one who remembers how degraded the creek corridor was 30 years ago, I think we can all feel proud of how far we have come.

The future will hold challenges as climate change and continuing urban development affect our local environment, so we need to keep working!

### Signage in Valley Conservation Reserve

Members who have visited Valley Reserve recently will have noticed the new signage at the entrances featuring the new layout and colour scheme for City of Monash. An updated map of the reserve showing walking tracks has also been provided. We believe that the bollard signs along the walking tracks will be the next to be updated.

### Cycle/Walking Track from Waverley Rd to Forster Rd

You may have noticed that a new cycle/walking track from Waverley Rd towards Forster Rd has been completed. The path now runs alongside the creek all the way from Waverley Rd to Forster Rd. This change is in connection with the planned development of a day-care facility for pre-school children on the site. The old path will soon be closed.

We are hopeful that bushland regeneration can be started along that stretch of the creek corridor in the near future.

With spring approaching, the Scotchmans Creek corridor and Valley Reserve should be looking at their best over the next few weeks as the flowers come out. The wattle trees are already putting on quite a show. It's a great time to reconnect with the beautiful local parks and reserves in our neighbourhood.

### Planting Program for 2022 - All complete:

### Friends Planting – Sunday 12 June:

800 plants in Valley Conservation Reserve. The Friends Group is funding the purchase of these plants.

### Friends Planting – Friday 17 June:

500 plants in the Mt Waverley Wetlands. Supplied by Melbourne Water.

### Crosby Drive Plantings – 20, 21 July:

3,000 plants installed by Australian Gas Infrastructure Group and Brentwood Secondary College students – the bush crew also planted some of them. Funded by a Melbourne Water grant.

### National Tree Day – 31 July:

8,000 plants in Fairway Reserve on the north side of the creek. Over 200 members of the public came along to plant our remaining plants funded by a Melbourne Water grant.

#### June

#### **Comments:**

• Valley Creek had 1 ppm ammonium (Degraded rating), which is unusually high for any of our sites and required dilution of the sample to be measurable with our test kit.

### **Habitat Assessments:**

Site 1a, Scotchmans Creek upstream of Crosby Drive/Turner Court. Extensive overgrowth of ivy and other introduced species in some areas. The scoring was 23/40, rated as Fair.

Site 1b, Glen Waverley Drain. Southern bank and verge has improved weed control. The scoring was 26/40, rated as Fair.

### July

#### **Comments:**

- Most of the physical/chemical indicators were Fair to Excellent at all the sites, except for turbidity • resulting from overnight rain showers.
- The habitats at the downstream sites were rated Fair to Good. The verge vegetation is especially • improved, but weeds remain on the creek banks.

#### Habitat Assessments:

Site 2, YSC020, Scotchmans Ck at Regent St. Dense, maturing vegetation on west bank (native vegetation) of very good quality. A lot of weeds along both banks, including ivy. Some non-native grasses. Some localised erosion on west bank. Considerable variation in stream width ranging from 0.5-3 m. Rated Fair.

Site 3, YVA100, Valley Ck at Regent St. South bank has extensive introduced weed cover. North bank and verge has good quality native vegetation. Good variety of in-stream riffles, pools and snags. No significant erosion, both banks are well vegetated. Rated Good.
