At the AGM, Emily Payne from Monash City Council was our guest speaker, and she gave a most interesting and informative talk on water sensitive urban design (WSUD) and water management generally.

Despite the last 2 wet years, water remains a precious resource which we need to be prepared to manage carefully. It can, as we can see all too well also be a potent force of destruction. We need to learn to live with our rivers and creeks carefully and with respect!

Part of the medium term management for Valley Conservation Reserve will focus on water management – as many will be aware, the entrance area to the reserve is prone to local washout across the Waimarie Drive/Wills Avenue junction, and this results in severe local erosion near the scout hut.

Emily will be contributing her expertise to help design a suitable solution to this problem, that respects the sensitive nature of Valley Conservation Reserve's natural environment and reduces or (hopefully) eliminates the erosion problem.

Two of our committee members (Kallista and Bharathy) plan to meet with Emily to discuss the problem, and to understand the proposed solutions. We'll keep you posted. We also hope to have Emily back in the near future to tell us more about water management in Monash and hopefully, the proposed solution for Valley Conservation Reserve.

Planning for 2023

In my address to the AGM, I made the point that this year has seen a (cautious) return to normality. Covid has not disappeared, and may be with us for the longer term, but we have managed to carry out our normal programs of planting, weeding, waterwatch and schools activities constrained more by weather than Covid.

The committee has already begun discussing our priorities for 2023. We want to make sure FSCVR continues to reach out and connect with the community even better next year. If you have any ideas you think would help, please let us know.

October

Comments:

- Due to sewerage spill into Site 3, no sampling was performed for health and safety reasons. Yarra Valley Water is aware of the issue and had tagged the area. Some hay bales were placed in the stream to assist cleanup. Vegetation around Valley Creek was noticeably sparse, perhaps due to ingress/egress of Yarra Valley Water. The photo below was taken from the footpath; Valley Creek is not normally visible from this viewpoint:
- Turbidity was Good (Site 1b) to Degraded (Sites 2 &1a); both downstream branches were muddled by heavy rain. Even so, the oxygen concentration at Site 2 was excellent.
- Ammonium results were excellent for Sites 1a, 1b & 2.
- The scheduled invertebrates sampling was not done due to high turbidity and fast flow making conditions difficult at site 2 (Scotchmans Ck) and due to remnants of the sewerage spill at site 3 (Valley Ck).

November

Comments:

- The scheduled invertebrates sampling was not done due to high turbidity and fast flow from previous day's heavy rain.
- As expected, Turbidity was Degraded for all sites; upstream and downstream branches were muddled by overnight heavy rain. Oxygen concentration at Sites 1a & 1b were excellent.
- Ammonium results were excellent for all sites.
- Stream flows are high Regent St Site 2 was flowing almost as fast as Fiander arm Site 1a! Valley Creek was at bankful.
