#### **August**

#### **Comments:**

- Flow in the YSC010 (Fiander Arm) was turbid (rated Fair) and there was an oily slick on the water surface. Despite this, the oxygen level was Excellent.
- The conductivity reading at Site YSC010 was Poor and that of Sites YSC012 (Glen Waverley drain),
  YSC020 (Regent Street) and YVA100 (Valley Creek) were Good.
- The turbidity readings at Sites YSC012 and YSC020 were Excellent (low results), but Poor for Site YVA100.
- The ammonium test results were obtained using new reagent (all sites were Good to Excellent). When samples from Sites 1b and 2 were tested with just expired (07/24) reagent, they gave readings of zero for both samples.
- It was noted that the amount of gravel/silt in the litter trap was significant. There was quite a bit of in-stream rubbish at both Sites YSC010 and YSC012.

#### September

#### **Comments:**

- The water in YSC010 (Fiander arm) was slightly turbid, compared to the water in YSC012 (Crosby arm) which was clear. Both sites have Excellent oxygen level.
- The ammonium test results were Excellent for sites YSC010, YSC012 and YVA100; it was Good for site YSC020.
- We recommenced our aquatic invertebrate sampling: the bug score was Poor. There was very low variability of species observed.



## Spring in Valley Conservation Reserve

Whilst out enjoying Valley Conservation Reserve and along the Scotchmans Creek corridor not only are you getting some of that much needed vitamin D from the sun, which we miss during the colder days, but also mental health benefits which come from being out in the natural environment – good for the immune system, cardio and well being.

You may notice there are many flowers blooming, some of the first to bloom were the acacias. As well as for plant reproduction, flowers provide food for native wildlife, so as tempting as it may be, please refrain from picking the flowers. You may like to consider planting some indigenous plants in your own garden, indigenous plants are well adapted to the area and therefore tolerant.

City of Monash have good information on planning an indigenous garden and which plants are suited to your local area in their "Monash Gardens for Wildlife" program. When joining their program you receive a free seedlings voucher and can attend workshops. You may wish to pick up one of their free booklets at our AGM. By creating an indigenous garden you are creating habitat for native wildlife and connecting the wildlife corridor for this wildlife to travel along.
